For guidance of Purchasers approximate weights or numbers of bales for each Lot are given in the catalogue, but it must be emphasized that this information is given for guidance only. NO WARRANTY AS TO WEIGHT, QUALITY OR CONDITION CAN BE GIVEN, ANY INTENDING PURCHASER SHALL BE DEEMED TO HAVE INSPECTED THE LOT IN WHICH THEY ARE INTERESTED. FOR INSPECTION OF ALL LOTS PLEASE CONTACT THE RELEVANT TELEPHONE NUMBERS PROVIDED.**
4. All lots must be paid for in full in the Sale Room at the termination of the sale.
5. **CHEQUES WILL BE ACCEPTED IN PAYMENT ONLY IF A SATISFACTORY REFERENCE IS GIVEN TO THE AUCTIONEERS BEFORE THE START OF THE SALE.**
6. At the fall of the hammer each and every Lot shall be considered as sold and thereafter will remain in every respect at the absolute risk of the respective Purchaser or Purchasers thereof.
7. All Lots must be removed within seven days unless otherwise given out at any time during the sale. The Purchaser shall indemnify the Vendor for any damages that may be caused to gates, fences, etc, in the cause of removal of any Lot.
